Her Excellency the Governor, on the advice of the Minister responsible for health, and in exercise of the power conferred by section 107B of the Public Health Act 1949, makes the following Regulations:

Citation

1 These Regulations, which amend the Public Health (COVID-19 Emergency Powers) (Phased Re-opening) Regulations 2021 (“the principal Regulations”), may be cited as the Public Health (COVID-19 Emergency Powers) (Phased Re-opening) Amendment (No. 10) Regulations 2021.

Amends regulation 2

2 In regulation 2 of the principal Regulations, at the end insert—

“Student 7-day Pass” means a pass issued, in accordance with guidance, confirming a negative COVID-19 test result in respect of a child between the ages of 5 and 11 years who is enrolled in a school

COVID-19 testing programme, which is valid for a period of seven days following the test;”.

Amends regulation 5

3 In regulation 5 of the principal Regulations, delete “30” wherever it appears and substitute “50”.

Amends regulation 6A

4 In regulation 6A(1) of the principal Regulations, subparagraph (c) is revoked.

Amends regulation 8A

5 In regulation 8A of the principal Regulations—

(a) in subparagraph (a), after “certificate” insert “or a valid Student 7-day Pass in the case of a child between the ages of 5 and 11 years who is dining with a parent or guardian,”;

(b) subparagraph (c) is revoked.

Amends regulation 17A

6 In regulation 17A(1) of the principal Regulations, delete “30” and substitute “50”.

Amends regulation 17AA

7 In regulation 17AA of the principal Regulations—

(a) in paragraph (1)(a), delete “30” and substitute “50”;

(b) paragraph (4) is revoked.

Commencement

8 These Regulations shall come into effect at 6am on 29 November 2021.
